2021-2022 Back to School provider program is being extended to June 30, 2022

Receive additional fee payments for preventive services

- As previously communicated, beginning October 1, 2021, you can receive extra fee payments by providing preventive care to Blue Cross members with Healthy Kids Dental coverage. This is a short-term addition to your value-based program. The time frame for you to receive extra payments under this program has been extended.
- You were previously informed you can receive up to \$100 in total additional fees per member, per visit, for preventive services performed October 1, 2021 through March 31, 2022. The end date for this program has now been extended through June 30, 2022.
- As a reminder, you will receive additional fee payments (in addition to the usual fees) for the following services:
 - ✓ Oral evaluations (D0120, D0145, D0150): \$50.00
 - ✓ Sealants (D1351, D1352): \$20.00
 - ✓ Fluoride (D1206, D1208): \$15.00
 - ✓ Cleanings (D1110, D1120): \$15.00
- File your claims as usual and the additional fee payments will be determined by the codes submitted on your claim. They will be paid in addition to your normal contracted rate for that code.
- Time limits:
 - Claims with dates of service from October 1, 2021 to December 31, 2021 must be received by January 31, 2022 to qualify. Your additional fee payments will be paid by March 31, 2022.
 - Claims with dates of service from January 1, 2022 to March 31, 2022 must be received by April 30, 2022 to qualify. Your additional fee payments will be paid by June 30, 2022.
 - Claims with dates of service from April 1, 2022 to June 30, 2022 must be received by July 31, 2022 to qualify. Your additional fee payments will be paid by September 30, 2022

- To receive reimbursement for services through a Medicaid managed-care plan, you must be actively enrolled in CHAMPS. Providers who are not enrolled in CHAMPS will not qualify for this program.
